Offer Procedures:

1. Bids are closed on Tuesday at 4pm Eastern Time. Offers are opened and the high offer on each vessel is submitted to the seller on Wednesday morning. The seller, at its sole discretion, may accept or reject the offer or make a counter offer. Responses usually occur within 48 hours.
2. All vessels are sold as is where is, with no warranties, express or implied, as to condition or fitness for a particular purpose.
3. A credit card number must accompany all offers submitted. Upon acceptance of an offer, \$1000 will be charged to the credit card. If the credit card is declined offer will immediately be voided.
4. Upon verbal notification of acceptance of an offer, buyer has 5 working days to complete any "conditions" as set forth and pay the amount due IN FULL via certified funds. Failure to close the transaction within 5 business days after notice of acceptance will result in the \$1000 deposit to be forfeited and the vessel placed back into the next auction cycle.
5. Bidder has 24 hours, or one business day, to remove the purchased vessel from the National Powerboat Auctions facility or make storage arrangements after closing. Storage charges will accrue on all vessels at our standard rates until vessel departs.

Notice to Customers Regarding Titling or Documentation

We exert extensive research to ensure that you are purchasing a unit with a clear title or USCG documentation. The \$299 administrative fee represents this research effort. It does not include transferring title or documentation. Buyers will receive from our title department all the documentation needed to complete the process. We can provide complete transfer of title or USCG documentation for an additional fee. Please contact our offices and ask to speak with our title department if interested.

Important Information Regarding Sales Tax

All purchasers will either pay sales tax at the current approved rate in their respective states or sign an out-of-state affidavit that they will pay their respective sales tax and provide a valid copy of a driver's license (with exception of Ohio and Florida residents who must pay tax directly to National Powerboat Auctions at point of sale). All dealers will be required to provide a state sales tax number, valid marine dealer's certificate or Statement for Exemption of Purchase.

Methods of Payment

By certified funds, financing, cash or bank wire. No drafts, personal or company checks or credit cards (other than the \$20 bid fee and \$1000 deposit) accepted.
